

2026 POLAND SPRING X YANKEES SWEEPSTAKES ("Sweepstakes")

Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

1. ELIGIBILITY: This Sweepstakes is only open to legal residents of, and residing in, the fifty (50) United States and the District of Columbia who are at least 21 years of age at the time of entry. Void where prohibited. Employees of BlueTriton Brands, Inc. 3. HOW TO ENTER: To enter, during the Sweepstakes Period:

3. In the comments, tag who you'll be taking with you to the game! Each comment with a tag count as an entry.
